 - (4) can teach introductory courses in the fields of data science and/or statistics.
- 2. The official status of this position will be either Designated Associate Professor (Term-Limited) or Designated Lecturer (Term-Limited) depending on the successful applicant's qualifications and experience.
- 3. The teaching load will be eight 90-minute classes per week for undergraduate and post-graduate students, including academic English courses in reading, writing, presentation, and communication.
